**The permit** is granted pursuant to 'Conditions for excavation on Port of Thyborøn land'.

A plan for signage must always be enclosed in case of work on public street / pavement.

The excavation permit cannot be granted if the application is not accompanied by a receipt for an excavation enquiry from the line owner register (LER).
